Ungraded shell eggs UPDATED

## All:

During the past few days, there have been more questions related to the use of ungraded shell eggs in retail food establishments. This message will hope to clarify these questions. This should be considered "official guidance" by the food program and supersedes all other prior messages related to the use of ungraded shell eggs.

The question has come up about the distinctions between a retail food establishment such as a grocery store and a restaurant. Historically, we have allowed the sale of ungraded shell eggs in retail food establishments like grocery stores but we have not allowed ungraded eggs in restaurants. This was due, primarily, to the difficulty presented to the inspector not having sufficient information to determine the origin of ungraded shell eggs and the end consumer not being made aware that ungraded eggs are in use within a restaurant setting. Due to the recent questions I have received, I've consulted with our Deputy Attorney General (DAG), Corey Cartwright. For reference, I've attached a letter that Corey wrote in 2010.

Guidance: If a producer of shell eggs is compliant with the applicable rules from the Idaho Department of Agriculture: <a href="http://adminrules.idaho.gov/rules/2011/02/0211.pdf">http://adminrules.idaho.gov/rules/2011/02/0211.pdf</a>, then the ungraded shell eggs may be distributed into a food establishment (including restaurants), without further regulation.

Please note that the Dep't of Ag rules exempt producers of shell eggs IF the producer has less than 300 hens, and clearly indicates that the eggs are ungraded. This means that in order to be used within a food establishment, the end consumer of the egg will need to know that the eggs are ungraded. The easiest way to do this would be to include some type of sign or posting on the menu that indicates: "We use ungraded shell eggs provided by \_\_\_\_\_" or similar language.

Other rules that apply in this case include Section 3-202.13 of the Idaho Food Code which reads: "Shell eggs shall be received clean and sound and may not exceed the restricted egg tolerances for U.S. Consumer Grade B as specified in 7 CFR Part 56....". Those restricted egg tolerances indicate that no more than 10% of the shell eggs can be checked eggs. Checked eggs include dirty eggs (presence of dirt or fecal material on the shell), cracked eggs, leaking eggs, etc. Once received, shell eggs are still required to be stored in coolers with an ambient air temperature of 41°F or less.

For field purposes, if you find ungraded eggs in a food establishment, they are considered to be from an approved source IF the producer of the eggs is in compliance with the Dep't of Ag rules, and if you are able to see that less than 10% of the eggs are checked eggs. If you find that more than 10% of the eggs are checked, or the end consumer of the eggs is not informed about the provider of the eggs and their ungraded status (requirements by the Idaho Dep't of Ag rules), then the eggs should not be used within the food establishment.

## All:

I apologize for the continuing messages about this topic. I am hopeful that this will put some finality to the issue. Below is the a message I have received from Marv Patten, Bureau Chief of the Dairy and Egg Bureau with the Idaho Department of Agriculture. This serves to clarify the status of a "retailer" vs. a restaurant or other food establishment.

In short, ungraded eggs are allowed for sale/distribution to the end user provided the egg producer meets the criteria that were oulined in a message from yesterday. However, a producer selling/distributing ungraded eggs to a restaurant is subject to securing a food establishment license from the local District Health Department.

Can you please confirm for me how Idaho Department of Agriculture defines "retailers" in this statement:

Idaho shell egg producers having three hundred (300) or less hens may sell ungraded shell eggs produced upon their premises to retailers, provided that each carton or other container of ungraded shell eggs sold shall be clearly marked "Ungraded" and shall bear the name and address of the Idaho producer.
